## 1. Report on draft Annual Plan 2014/15 Submissions and Further Information

Document A1183685

A report titled Report on draft Annual Plan 2014/15 Submissions and Further Information is attached to be considered as a major late item at this meeting. This report was listed as item 6 on the public agenda for the Council meeting to deliberate on submissions to the draft Annual Plan 2014/15 on 27, 28 and 29 May 2014 to ensure elected members were aware that it would be presented to this meeting.

# Report on draft Annual Plan 2014/15 Submissions and Further Information

## 1. Purpose of Report

- 1.1 To consider and make decisions on submissions to the draft Annual Plan 2014/15.
- 1.2 To provide further information on other matters raised during the draft Annual Plan Hearings.

## 2. Background

- 2.1 Council undertook a special consultative procedure for its draft Annual Plan 2013/14 from 28 March 2014 to 28 April 2014, in accordance with Section 85 of the Local Government Act (LGA) 2002.
- 2.2 211 submissions were received over the course of the consultation and Council met to hear submitters over 13 and 14 May 2014. 15 late submissions were also approved by Council to be considered. Other matters raised during the hearings that required further information have been added to relevant report sections below or submission comments as appropriate.
- 2.3 Council must now deliberate on submissions, ensuring that reasons for any decisions are made clear so that this can be conveyed to submitters as per the Local Government Act (LGA) 2002, Section 82(1) (f): 'that persons who present views to the local authority should be provided by the local authority with information concerning both the relevant decisions and the reasons for those decisions.'

## 3. Council Activity Areas

The report covers each activity area in turn. Key issues are dealt with first, with officer comments and recommendations on smaller items being contained in Attachment 1 (A1183986). At the end of each activity area Council is asked to approve the officer recommendations in Attachment 1 as the basis for responding to submitters.

## 4. Community Assistance

4.1 It is noted that there are a number of submissions requesting financial support which officers recommend should be directed to the Community Assistance funding round. It is important that groups that accept contracts should not receive additional amounts through the Annual Plan process and that all groups should be assessed fairly through the same process against the same criteria.

## 5. Transport

#### Cycling

5.1 Cycling related issues attracted many submissions, mainly focussed on the Velodrome, regional cycling issues, Bikefest and connections.

#### Velodrome

- 5.2 21 submissions (40, 42, 43, 44, 45, 46, 47, 51, 52, 53, 59, 62, 64, 65, 66, 73, 89, 107, 108, 128, 152) supported Council funding for the velodrome being built at Saxton Field.
- The funding for the velodrome in the current financial year has underspent somewhat due to delays caused by design issues. However the powerlines have been successfully relocated and the project is progressing with both Councils maintaining their commitment to it. Relaying of the grass at Trafalgar Park, which would close the cycling track there, will be delayed until the velodrome is open. Submitters will be advised that Council supports the velodrome project and there is funding allocated in 2014/15.

#### **Regional Cycling Framework**

Seven submissions (180,182, 184, 17, 48, 92, 126) requested Council support for a regional cycling framework as drafted by a new group, the Nelson Tasman Cycle Forum (at which Council was represented in the last triennium but has not had resource to participate in since). This Forum was initiated in 2013 with the aim of better coordinating cycling in Nelson Tasman and the framework was a result of this work. It would seem appropriate for Council to indicate support for an initiative which brings cycling groups together to collaborate in this way. Submitters will be advised that the suggestions for Council projects will be taken into account by officers in the priorities being developed in the Transport Activity Management Plan 2015-25 which will, in turn, inform the Long Term Plan 2015-25.

#### 5.5 Recommendation:

<u>THAT</u> Council convey its support for the establishment of the Nelson Tasman Cycle Forum and look for opportunities to collaborate with the Forum as it seeks to enhance the environment for cycling in the Nelson Tasman region.

## Linkages

Two submissions (126, L2) want progress on a Tahuna back beach cycleway to link to the Great Taste Trail and will be advised that the Tahunanui cycle network is being investigated in the current financial year in order to understand the links necessary to connect the coastal cycleway and railway reserve with the proposed Rocks Road facility. The current programme shows physical works for the links in the 2015-18 programme.

#### **Bikefest**

5.7 Submission 109 requested Council support of around \$8,000 plus staff time for Bikefest in January/February 2015. Officers suggest that Bikefest be asked to submit an application for the Community Assistance funding round which is expected to commence in July this year. That will allow a fair process where this proposal is evaluated against other community projects. The timing of the festival means it would not be eligible to apply under the Events Fund with its current focus on the March to November period. It is also noted that this submission requested support for the BMX Club but could not provide any details of the support needed and so withdrew the request at the hearings.

## Matangi Awhio Walkway

- The land known as Matangi Awhio (Auckland Point) is owned by Wakatu Incorporation and includes a walking track from the bottom of Haven Road to Stanley Crescent. This track was well-used by the public but has been closed since damage by a landslip. A number of submissions (79, 81, 87, 106, 112, 127, 163, L6) have requested that it is repaired. Officers understand that Wakatu Incorporation has not undertaken remediation work because of the likely cost and the ongoing instability of the site.
- 5.9 This is an unstable area and a geotechnical report (estimated at \$50,000) would be required before the cost of reinstatement could be estimated. The New Zealand Transport Agency walk/cycle funding cannot be used as the path is on private land. If reinstatement of the path occurs, given the unstable site, an allocation for ongoing maintenance would need to be made either by the owner or by Council.

- 5.10 The submission from Paul McArthur (106) suggests an alternative route be explored from the end of the unformed section of Stanley Crescent. Officers recommend that this be investigated before the question of allocating funds for a geotechnical report of the existing walkway route is considered.
- 5.11 Recommendation:

<u>THAT</u> an investigation be undertaken into options for reinstating walkway access through land known as Matangi Awhio and the results reported to the Works and Infrastructure Committee.

## **Railway Reserve Lighting**

One submission (83) requested lighting the Railway Reserve, but this also came up during hearings and has been an issue in previous years. Officers indicate that the cost of lighting the length of the Railway Reserve is prohibitive and is currently not included in planned work programmes. An indicative cost for lighting the full length of the walk/cycleway is \$2.7 million.

## Rocks Road Cycle/Walkway

5.13 11 submissions supported the Rocks Road Cycle/Walkway (184, 167, 17, 23, 83, 84, 100, 126, 133, 170, L7), and four opposed (117, 177, 194, L2). Other submissions raised a range of concerns, including a desire for a more strategic approach and the need for further investigation of the need for the project. Submitters will be advised of progress on the project and the next stages of the investigation.

## **Bridge Street Enhancement**

- 5.14 Nine submissions (80, 23, 83, 92, 96, 117, 121, 173, 178) supported Council's proposal in the draft Annual Plan 2014/15 to add funding for the enhancement of Bridge Street, specifically to increase daytime amenity. One of these submissions asked Council to expand the work it is doing on Bridge Street and another hoped the funding could include artworks. One submission (87) did not see this as a priority for Council funding.
- 5.15 The current project to enhance Bridge Street with seats, lighting, paving and landscaping features will be completed by June 2014 and take approximately one to two weeks using a budget of \$218,000.
- There was a request for more consultation, which has reduced in recent times. Significant consultation happened in the early stages of the project but in recent months the project has moved to the design and implementation stage. In the next financial year, if additional funding is approved as proposed in the Annual Plan, there will be another round of

- consultation with key stakeholders to determine the best approach to achieve safety and further visual enhancement of the area.
- 5.17 Submitters will be advised that enhancing the amenity and safety of the Central Business District is a priority for Council and the support for this initiative is appreciated.

#### 6. Waste Water

#### **Individual Wastewater Submissions**

- 6.1 Officer comments for submissions 130, 189, 48, 141 are listed in Attachment 1.
- 6.2 Recommendation

<u>THAT</u> Council approves the officer recommendations for submissions 130, 189, 48 and 141 in Attachment 1 (A1183986).

#### 7. Stormwater and Flood Protection

- 7.1 Tod Valley Stream and Wakapuaka Sandflats
- 7.2 Three submissions (157, 172, 175) requested immediate resolution of flooding issues on the Wakapuaka Flats/ Tod Valley by clearing drains and unblocking culverts. Another submission (96) supports the work as a priority for Wakapuaka Sandflats flood control. One submission supports the flood protection work on the State Highway, because it will benefit the Wakapuaka Wildlife Reserve (14).
- 7.3 Council has an ongoing budget for maintenance of the drains on the Wakapuaka Flats. This budget is spent in consultation with the various landowners. To alleviate immediate flooding concerns, Council is upgrading the culvert on the state highway and developing a single resource consent application to allow for the maintenance of the drains within the wider Wakapuaka flats area.

- 7.4 In the longer term, an options report for the future upgrading of the stormwater network through the Wakapuaka flats from Glen Road to Boulder Bank Drive is programmed for 2020/22, with a budget of \$150,000 to look at a comprehensive flood protection strategy for the area in consultation with stakeholders. This will be part of the Nelson Plan, which will also look at options to return the sandflats to tidal action.
- 7.5 It would be possible to advance consideration of the stormwater network upgrade and a first step would be to include \$50,000 in the 2014/15 budget to begin the process of working through issues with affected parties. Consideration of subsequent costs would then be part of the development of the Long Term Plan 2015-25.

<u>THAT</u> \$50,000 be allocated in the draft Annual Plan 2014/15 to begin work with affected parties on options for an upgrade of the stormwater network through the Wakapuaka flats from Glen Road to Boulder Bank Drive.

#### Maitai River Weir

7.6 Two submissions (34, 138) proposed investigation of a weir on the Maitai River. This proposal has been raised in the past and some investigation of options has previously been undertaken by officers. In the case of the graded riverbed approach advocated in submission 34 a number of environmental impacts were identified including reduced water quality, potential for bacterial contamination, adverse impact on the habitat for benthic communities that live and feed in the tidal habitat plus potential contamination due to movement of sediment in the lower Maitai given its higher than recommended levels of hydrocarbons. If Council wishes to pursue the possibility of a weir it is suggested this could be covered as part of the work on the Maitai River (see below).

#### 8. Environment

#### Maitai River

There was a great deal of submitter interest in Council's proposal to fund a range of projects to improve the health of the Maitai River. Nineteen submissions (33, 38, 91, 176, 179, 23, 48, 83, 92, 94, 112, 130, 155, 168, 170, 173, 178, 188, L12) support the funding.

One submitter was concerned at the lack of detail of how the funding would be applied. The projects to be covered by the Maitai River enhancement project are as follows:

Total	\$400,000
Flood Hazard	\$60,000
Riparian planting	\$50,000
Land Management	\$30,000
Dam management	\$60,000
Amenity improvements	\$30,000
Fish Passage Measures	\$100,000
Community engagement and support	\$70,000

- 8.3 Friends of the Maitai in its submission (179), while noting it was not a funding application, did indicate it would appreciate some funding for community initiatives. Officers will suggest that the group make an application to the upcoming Community Assistance funding round.
- 8.4 There were a range of suggestions on ways to improve the Maitai River and its immediate environment. These will be taken into account by staff as the work programme rolls out.

## 9. Air Quality

9.1 Five submissions (103, 168, 170, 173, 193) support a review of Council's approach to woodburners. The Nelson Marlborough District Health Board's submission (92) supports modelling work and wants to avoid any backwards step on air quality. Submitters will be advised of the process Council has agreed for pursuing this issue and the timing of next steps.

## 10. Social including Arts and Heritage

#### **Nelson School of Music**

- 10.1 A majority of submitters on the School of Music (76, 99\*, 140, 169, 190\*, 197, 199, 23, 83, 96, 106, 133, 173, 178, 194, 131, 168 \*both from School of Music) approve of Council's ongoing support for the institution with just one disagreeing on the grounds that it should be financially viable without Council intervention.
- 10.2 The School of Music has requested increased financial support be added to the draft Annual Plan through a \$20,000 provision for the Winter Festival and \$80,000 operational funding. As noted during discussions on the draft Annual Plan 2014/15 in February the closure of the School of Music auditorium reduces the outcomes that Council is able to purchase from the School and that led to a reduced operational grant being included in the draft Annual Plan. The Local Government Act 2002 Amendment Act 2012 introduced provisions which mean that when grants are given to community groups Council must clearly specify the public service being purchased and demonstrate the cost-effectiveness of the provision.
- 10.3 The School of Music in its verbal submission indicated it considered that it could justify, in terms of outcomes, an increased funding allocation being made in the draft Annual Plan. It is suggested that the draft Annual Plan 2014/15 include up to \$100,000 of funding to purchase outcomes from the School of Music and that officers work with the School's Board to identify those in more detail. Agreement to those items to be purchased would be subject to Council approval through a subsequent report.
- 10.4 The School of Music submission also requested continuing active involvement by Council in developing plans for support of the School's earthquake strengthening and redevelopment. This close collaboration has been in place for some time and Council reiterated in the draft Annual Plan its commitment to supporting the School through this process.
- 10.5 In addition the School of Music requested increased funding for the arts and cultural infrastructure/activity/facilities in Nelson and a plan for the sustainability of the arts sector. Long term funding for the arts is most appropriately considered through Council's Long Term Plan 2015-25 and the Nelson Tasman Regional Arts Strategy provides a framework for supporting the sustainability of the Nelson arts sector.

#### 10.6 Recommendation:

<u>THAT</u> an allocation of \$100,000 be made in the Annual Plan 2014/15 for the purchase of outcomes from the Nelson School of Music, subject to approval of a timetable of deliverables by Council through a subsequent report.

## **Theatre Royal**

- 10.7 Eight submitters (76, 23, 83, 96, 106, 133, 178, 194) supported the increase in operational funding for the Theatre Royal proposed in the draft Annual Plan 2014/15. Four submitters (103, 161, 168, 173) were concerned about the Theatre's viability or did not support Council's planned funding.
- 10.8 Submitters will be told that Council has undertaken due diligence on the Theatre's finances and believes the funding allocated is justified to ensure community outcomes continue to be delivered from the Theatre.

## **Arts Council Funding**

- 10.9 A number of submissions (50, 63, 76, 85, 169, L4) expressed concern about the level of funding for the Arts Council Nelson. The Arts Council itself suggested it was time to rethink the relationship with Council and to look at what community outcomes it could deliver. It would like to become a cultural broker active in developing and administering arts projects and events in collaboration with Council.
- 10.10 Arts Council Nelson is currently is in its third year of a four year contract of \$40,000 per annum. This contract assists with the delivery of the Arts Policy and Regional Arts Strategy and is meeting many aspects of the community outcomes. When considered for funding in 2011/12 it was ranked highly by staff and met all aspects of the funding criteria. Arts Council Nelson has been a long term recipient of community assistance funding (in 2008/9 it received a contract for \$35,500 per annum and from 2009/10 to 2010/11 received \$40,000 per annum). Arts Council Nelson also receives \$5,000 annually from Council to administer the Creative Communities local funding scheme. Officers consider Arts Council Nelson has delivered well on all its contracted outcomes.
- 10.11 Arts Council Nelson is in a difficult financial position and although its situation has improved over the last few years it has nonetheless been operating in deficit. As mentioned at the hearings Arts Council Nelson is currently running a deficit of \$7,023 and they expect this to increase. There is a pending funding application to Canterbury Community Trust which would address the deficit situation.
- 10.12 The possibility of the Arts Council assisting with the allocation of the Arts Fund in the draft Annual Plan is something that could be explored by officers in discussion with the Arts Council (noting that this is capital funding, not operational). The terms of a contract, specific deliverables and timeframes would all need to be worked through. For Council to have a good understanding of what could be achieved this should be the subject of a separate report.
- 10.13 Suggestions on this topic from submitters included that the Arts Fund be spent on education classes/workshops, improving salaries for Arts Council employees, welcome to Nelson signage and landscaping for the

Buxton carpark. These matters can be considered as part of the further report.

#### 10.14 Recommendation:

<u>THAT</u> a further report be prepared on the best way to allocate the \$125,000 of capital funding in the Arts Fund included in the draft Annual Plan 2014/15, including the role that may be provided by Arts Council Nelson.

## **Refinery Gallery Earthquake Strengthening**

- 10.15 The Kahurangi Employment Trust /Refinery Artspace submission (165) and others (76, 85, 169, 199, L4) requested Council funding for earthquake strengthening the building. The Refinery has an earthquake rating of 11%NBS and has a Section 124 Notice attached to it requiring strengthening or demolition by 30 June 2032. Strengthening costs to 67% are estimated at \$1Million. Council is undertaking detailed assessments of all its building assets (anticipated to be completed by June 2015). Council will then be in a better position to consider priorities and officers recommend no ad hoc earthquake strengthening work is carried out until that full picture is available.
- 10.16 The building has a very low earthquake assessment but is not deemed unsafe to be occupied. Kahurangi Employment Trust and Arts Council Nelson have leases which expire 31 March 2015 and officers will be recommending lease renewal.
- 10.17 The Council has previously considered the Refinery's accounts and decided not to fund its bottom line. However this could be considered again through an application to the Community Assistance Fund where the outcomes to be delivered could be prioritised against other applications for funding.

#### **World War I Commemorations**

- 10.18 The presentation to the hearing from the Nelson RSA drew attention to the likely scale of commemoration services, particularly the ANZAC day service in 2015, and the fact that this would exceed its ability to fund.
- 10.19 The Nelson Provincial Museum is providing a coordination service for groups involved in commemorations. Council is giving the Museum \$2,000 per year over the five year period to assist with commemorations projects. Council has also allocated \$30,000 to the RSA for a sculpture for Marsden Cemetery (on the basis that the funding is available if other sources cannot be found). This sculpture is due to be installed in April 2015, however a finalised concept and budget have not been made available to officers. The RSA also received \$2,100 from Community Assistance funding this year for ANZAC Day street banners.
- 10.20 Given the importance of the commemorations and the scale of attendance likely at ANZAC day services next year it would seem prudent

to allocate some additional WWI commemoration funding which could be directed to appropriate projects in 2014/15. There is currently \$10,000 allocated in the draft Plan for WWI commemorations, in addition to items outlined above, and it is suggested this be increased to \$50,000.

#### 10.21 Recommendation:

<u>THAT</u> funding of \$50,000 be included in the draft Annual Plan 2014/15 to be used for WWI commemorations as necessary.

## **Community Assistance Fund**

- 10.22 The Nelson Community and Whanau Network submission (122) requested a more transparent process for allocation of funds as at present applicants were often confused as to why they did not receive funding. Council in the past has considered and trialled a number of different approaches to community assistance funding all with their advantages and disadvantages. The concerns of the Network in this instance seem to mainly relate to the process whereby officer assessments and rankings of applications are conveyed before Councillors have considered applications and this leads to expectations being formed about the likelihood of funding.
- 10.23 The call for applications for the next funding round is scheduled for early July 2014 and it is proposed that staff do not undertake or convey assessments before the hearings but instead prepare a report afterwards with relevant information for Council to consider at its decision-making meeting. Once allocation decisions have been made applicants would be advised of the reasons for Council decisions.
- 10.24 The Community Assistance Policy is due for review in June 2015 and the effectiveness of this change in process can be assessed as part of that review.

#### 11. Parks and Active Recreation

## **Trafalgar Centre**

- 11.1 The Trafalgar Centre was another important issue for submitters with a total of 21 commenting on it. Ten submitters (116, 143, 183, 100, 142, 168, 177, 194, 161, 173) supported immediate reopening. Other submitters had a range of views with some wanting further assessment, some opposing further expenditure on the building and some encouraging an immediate decision.
- 11.2 A workshop with a group of experts was held on 7 May to discuss the Trafalgar Centre. A process on how Council best moves this issue forward has not yet been determined.
- 11.3 Submitters will be advised that decisions on the future of the Trafalgar Centre will not be made through the Annual Plan 2014/15 deliberations but in a separate Council process already underway.

#### **Modellers Pond**

- 11.4 Many submissions were received on the Modellers Pond. Eight (102, 104, 151, 153, 83, 161, 168, L2) supported retention of the pond although one suggested using windmills to address the weed problem. 15 submissions (17, 67, 129, 186, 48,60, 84, 94, 101, 106, 141, 170, 173, 177, 23) wanted the pond filled in or no ongoing funding for the project.
- 11.5 Officers are continuing to investigate using fish to achieve a cost effective solution that controls the weed and algae issue in the pond. Also needed is some work on the tidal gate to prevent ingress of salt water during king tides, to prevent the fish from being swept away and to create shaded areas for fish if needed. The solution will not include any changes to the overall shape and margins. Over winter Nelmac will continue to clean out the ponds and in spring fish will be introduced. If using the fish does prove to be a viable solution, then certainly a large portion of the \$500,000 set aside in the Annual Plan for 2014/15 will not be required. However if this proves not to be the case then a solution that will cost more will need to be further explored.

## Stoke/Greenmeadows

- 11.6 Seven submissions (2, 164, 23, 83, 103, 106, L3) support the proposal to allocate \$200,000 in 2014/15 for the investigation and design of a new community and sports facility in Stoke. One of these submissions (from the Stoke Rugby Club) attaches a number of other letters of support from other sporting and community groups. One submission (17) does not support the proposal, because it comes on top of a large ratepayer investment in nearby Saxton Field and another (178) is doubtful and suggests deferral.
- 11.7 Submitters will be advised that this facility is important for the Stoke community and Council is committed to progressing it.

## **Brook Camp**

11.8 23 submissions were received on the Brook Camp issue (5,7,10,12, 19, 28, 30, 31, 39, 87, 113, 145, 101, 154, 155, 162, 168, 170, 191, 193, L9, L10, L11) with one requesting further investigation but all the others supporting the camp remaining open. Submitters will be advised that no proposal to close the Brook Camp was formally released and discussions on the future of the camp are being progressed through a separate process in the Community Services Committee.

## **Aquatic Facility**

- 11.9 The Nelson Sea Sports Alliance and Sport Tasman submissions both supported investigation of a water sports facility for Nelson. A Water Sports Review produced by Sport Tasman had \$3,000 of funding from Nelson City Council.
- 11.10 The Alliance submission sets out a number of actions it would like to see from production of a feasibility study to employment of a water sports development officer to development of a marketing plan. The main concerns are around inadequacy of current facilities, safety issues and poor storage.
- 11.11 Officers consider there is a need to work with this group of users to address concerns about adequacy of current facilities and to explore possible solutions. At this stage it is recommended that an allocation of staff resource only be made and that a report be brought to Council looking at the issues, options and costs.
- 11.12 Recommendation:

<u>THAT</u> a report on the needs of water sports groups in Nelson be prepared for Council during 2014/15 with a view to identifying issues and options and any further work that needs to be scheduled in the Long Term Plan 2015-25.

#### Marina

11.13 Submissions 187, 156, 106 support the hardstand proposal. The first two raise a number of other concerns about the Marina.

#### Hardstand

- 11.14 Council formally resolved in August 2013 not to purchase 1 and 5 Cross Quay (haul-out structure, the travel lift, travel lift business and hardstand).
- 11.15 Funding has been placed in the draft Annual Plan to either: a) seek a variation to the consent or b) provide the additional area. Council has land to accommodate a hardstand area, but does not have consent to allow boats to undertake work on this land and this is enforced. This

needs to explored further in terms of what Council wants to do in the Akersten area as a whole.

The Youth and Community Trust requested that Council, in undertaking the review, consider whether it has a venue that could house a youth specific venue that can house events and services.

## **Digital Strategy**

12.2 The Chamber of Commerce submission requested support for the development of a Digital Strategy. The Economic Development Agency has this in its work programme for 2014/15 but indicated it would not have sufficient funding to complete a strategy. It estimates completion of a strategy would cost between \$50,000 and \$75,000 and that it would be able to contribute approximately \$20,000 towards that amount.

breakfast room with or without kitchen facilities'. QV has advised that there is no easy way to know if there are many more dwellings/flats (with separate kitchens) being run as B & B operations as they are simply identified as dwellings and flats in the database so officers will have to manually check these annually (likely to be less than 10 properties affected).

#### 13.2 Recommendation:

<u>THAT</u> the definition of Separately Used or Inhabited Parts of a Rating Unit (SUIP) be changed to exclude "a bed and breakfast room with or without kitchen facilities".

## 15. New Budget Items

15.1 Since the consultation on the draft Annual Plan some new items of expenditure for the 2014/15 year have come to light. Officers recommend these are included in the 2014/15 budget for adoption as part of the Annual Plan 2014/15.

## **Nelson Wastewater Treatment Plant Rising Main**

15.2 The Atawhai rising main recently broke at Marybank sending untreated sewage into the Haven. Officers remain confident that the programme outlined in the draft Utilities Asset Management Plans is realistic in terms of future work with the Atawhai rising main. However it would seem prudent to allow some funding next financial year to undertake non-invasive testing of the remainder of the concrete sections of the pipe. An amount of \$100,000 is required for this inspection work.

#### 15.3 Recommendation:

<u>THAT</u> an allocation of \$100,000 capital funding is made in the Annual Plan 2014/15 for non-invasive testing of the Atawhai rising main as a precautionary measure against future breaks.

## New Stock Effluent facility in Richmond

15.4 Council has previously approved funding for a shared project with the New Zealand Transport Agency (NZTA) to develop a stock effluent facility in Richmond. Design and planning is all but complete with tenders ready to be called. Investigations into issues relating to disposal of the effluent to Bell Island (via Tasman District Council's reticulation system or trucking) have been undertaken by NZTA and its consultants. Results of that investigation show that trucking the effluent is the only viable option and attracts the lowest NPV (net present value) costs. This trucking will attract an operational expense of \$50,000 annually (shared 50/50 between NZTA and Council) and will need to be included in the 2014/15 budget and annually thereafter.

#### 15.5 Recommendation:

<u>THAT</u> an allocation of \$50,000 operational funding is made in the Annual Plan 2014/15, and noted as an annual commitment thereafter, for trucking stock effluent to Bell Island from the Richmond Stock Effluent Facility.

#### 16. Contaminated Soil

16.1 At the end of 2013 Council loaded the Hazardous Activities and industries List site database on NMAP. Officers are now able to identify sites where capital works projects will potentially trigger the National Environment Standard for Assessing and Managing Contaminants in the Soil to Protect Human Health. When such sites are identified soil testing may be

required and it is recommended that an indicative sum is included in the draft Annual Plan 2014/15 for this purpose.

#### 16.2 Recommendation:

<u>THAT</u> an allocation of \$50,000 operational funding is made in the Annual Plan 2014/15 to cover the cost of soil testing at capital works sites necessary for compliance with the National Environment Standard for Assessing and Managing Contaminants in the Soil to Protect Human Health.

## 17. Audit NZ Comments on the draft Annual Plan 2014/15

17.1 Although the Annual Plan does not require auditing, Audit NZ was sent a copy for information. It reviewed the draft and has suggested technical changes which will be accommodated in the final document.

#### 18. Conclusion

18.1 Under the Local Government Act 2002 Council is required to consider submissions and to provide submitters with information on the relevant decisions and reasons for the decisions. This report contains information and recommendations to assist Council in its deliberations.

In summary, following this review our consultants advise that the site conditions between Cowles Stadium and the Trafalgar Centre are very different and that: the primary concern for the Cowles Stadium site was global and differential settlement whereas the primary concern on the Trafalgar Centre site is lateral spreading and its effects. Cowles stadium is located over one kilometre from the nearest river bank or similar, whereas the Trafalgar Centre is surrounded on three sides by stream banks with the closest around 20m from the building. Finally, our consultants also note that the "ETABS" analysis Mr Thompson refers tothat he believes should be used on the Trafalgar Centre was not used in the assessment of the Cowles stadium. I can also add that Mr Mike King (American now NZ based structural engineer in ChCh) advised officers (before his meeting with the Mayor, councillors and invited guests) that ETABS computer software and microstrain (which Holmes Consulting uses) are very much the same and that either is an acceptable package.
