# Temporary Extension of Liquor Ban – Saxton Field Reserve

#### 1. Purpose of Report

1.1 To consider extending the alcohol ban at Saxton Field Reserve on Cricket World Cup match days.

#### 2. Delegations

2.1 Temporary extensions of the liquor ban for specific events is a decision of Council (\$7.1 of Bylaw 206 Control of Drinking in Public Places).

#### 3. Recommendation

<u>THAT</u> the report Temporary Extension of Liquor Ban – Saxton Field Reserve (A1298345) and its attachment (A1299664) be received;

<u>AND THAT</u> a temporary 24 hour liquor ban be confirmed for Saxton Field Reserve (with the exception of the Saxton Oval) for the following specific events:

- Cricket World Cup Match West Indies v Ireland on Monday February 16, 2015;
- Cricket World Cup Match Zimbabwe v United Arab Emirates on Thursday February 19, 2015;
- Cricket World Cup Match Bangladesh v Scotland on Thursday March 5, 2015.

#### 4. Background

- 4.1 Council Bylaw 206 (Control of Drinking in Public Places) sets out areas and specifies times where the consumption of liquor is prohibited.
- 4.2 Saxton Field Reserve is currently listed in schedule A2 of the Bylaw as being an area where "the Period of Prohibition is from 9.00 pm on any day to 7.00 am on the day following during the period of daylight saving and from 7.00 pm on any day to 7.00 am on the day following for the rest of the year".

- 4.3 Council has been approached by the NZ Police to extend the Period of Prohibition to the entire day for Cricket World Cup match days (attachment 1).
- 4.4 Section 7.1 of the Bylaw states:

"The Council may, where it considers it appropriate for the safe and effectual holding in any public place or part of a public place of any public event, function or gathering, by resolution publicly notified no less than 14 days before the event:

- 1. Prohibit the consumption of liquor in the specified public place during that period or periods, the bringing of liquor into the specified public place during that period or periods, and the possession of liquor in the specified public place during that period or periods;
- 2. And may also in conjunction with the prohibition relating to liquor in (1) above prohibit the presence or use of any vehicle in a public place."
- 4.5 The three match days are 16 & 19 February and 5 March 2015.

#### 5. Discussion

- 5.1 Council needs to consider if a temporary extension of the liquor ban on Saxton Field Reserve is appropriate to ensure public safety and the effective delivery of the Cricket World Cup events.
- 5.2 The Cricket World Cup 2015 (CWC 2015) organisers have developed venue regulations for each match venue in New Zealand. These specify that people will not be permitted to take alcohol through the turnstiles at Saxton Oval on match days. It would seem sensible to extend the liquor ban to cover the whole of Saxton Field (barring inside the venue) to allow police to deal with any issues in the lead up to the matches.
- 5.3 Up to 6000 people are expected and officers believe this recommendation is reasonable in order to ensure their safety and enjoyment as they approach and leave the match venue.
- 5.4 Alcohol will be on sale at the match venue from CWC 2015 approved suppliers during the matches.

#### 6. Options

- 6.1 Council has to decide to extend the ban or not.
- 6.2 If Council decides not to extend the ban, the Police would still be able to deal with unruly behaviour as it arose, but would not be able to seize and remove liquor being carried. This could raise the risk of confrontation when anyone carrying alcohol reaches the match venue and is refused access.

- 6.3 Extending the ban gives police additional powers to search containers (e.g. bags) for liquor, and to seize and remove any liquor found. It also allows Council to advertise the fact that a liquor ban is in place.
- 6.4 In order to extend the ban, Council needs to consider if increasing the restrictions on liquor consumption are appropriate for the safe and effectual holding in Saxton Field Reserve of the Cricket World Cup 2015 matches (as per Bylaw 206, see 4.4).

# 7. Assessment of Significance against the Council's Significance Policy

7.1 This is not a significant decision.

8.1 This recommendation is consistent with the Council's Bylaw and Council outcomes of Kind, Healthy People and People Friendly Places.

#### **Temporary Road Closures**

#### 1. Purpose of Report

- 1.1 To advise of an incorrect interpretation of the requirements relating to temporary road closures for community, recreational and sporting events.
- 1.2 To seek retrospective approval for previously incorrectly processed temporary road closures for events proposed on the following dates:
  - Tug of Peace: 28 January 2015;
  - Buskerburgoo Street Theatre and Buskers Festival: 29 to 31
     January 2015;
  - Monster Slide: 2 February 2015;
  - Mike Pero Trolley Derby: 14 March 2015.
- 1.3 To seek approval for new temporary road closures for events proposed on the following dates:
  - Cricket World Cup Festival and Uniquely Nelson Market: 14
    February 2015;
  - Celtic Pipe Band Championships: 14 March 2015.
- 1.4 To provide information of upcoming temporary road closures for events that are yet to be processed by Council Officers and will be reported in full to Council at a future meeting.
  - Weet-Bix Kids TRYathlon: 8 March 2015;
  - Organised Stopping Distance Demonstrations: 16, 17, 19 and 20 March 2015.

#### 2. Delegations

2.1 The Local Government Act 1974, Schedule 10, confirms that approvals for temporary road closures for event related activities lie with Council.

#### 3. Recommendation

AND THAT Council note the application for the Weet-Bix Kids TRYathlon temporary road closure of Beach Road from 17 Beach Road to Golf Road, and Golf Road from Beach Road to Parkers Road and Hounsell Circle, on 8 March 2015;

<u>AND THAT</u> the Weet-Bix Kids TRYathlon temporary road closure be considered at a meeting on 12 February 2015;

AND THAT Council note the application for the Organised Stopping Distance Demonstrations temporary road closures of Nile Street on 16 March 2015, Bisley Walk on 17 March 2015, Tipahi Street on 19 March 2015, and Atawhai Crescent on 20 March 2015;

<u>AND THAT</u> the Organised Stopping Distance Demonstrations temporary road closures be considered at a meeting on 12 February 2015.

#### 4. Background

#### **Revised Interpretation of Legislation**

- 4.1 The Local Government Act 1974, Schedule 10, sets out the requirements for the temporary prohibition of traffic from road reserve.
- 4.2 Clause 12 of the Schedule describes the powers conferred on Council to enable roads to be temporarily closed. This clause states that approval of the majority of road closures can be delegated to Council officers with one specific exception described in clause 11(e).
- 4.3 Clause 11 distinguishes between temporary road closures, required for core activities that are maintenance oriented, and those that relate to events of a social, community or sporting nature. The exception described above, referred to as Clause 11(e), confirms closures associated with events cannot be delegated to Council officers. This distinction had not been captured in Council procedures. This means some closures have been assessed by Council officers rather than Council.
- 4.4 Council's procedures for Temporary Road Closure have now been updated to ensure compliance with Schedule 10 of the Local Government Act 1974. Should the approval of temporary road closures be able to be delegated to a committee this would need to be allowed for within the delegations register and officers would bring a report to Council to make such an allowance.

#### **Requirement to Seek Views of Affected Parties**

- 4.5 Schedule 10 of the Local Government Act 1974, Clause 11A, requires Council to give public notice of its intention to consider closing a road. It does not require the calling of submissions or the consideration of objections.
- 4.6 Section 78 of the Local Government Act 2002 states that a local authority must, in the course of its decision making process, give consideration to the views and preferences of persons likely to be affected by the decision.
- 4.7 By seeking the views and preferences of those people who are likely to be affected by the proposed temporary road closure, in accordance with Section 78 of the Local Government Act 2002, better information can be provided to aid decision making. For example, affected residents may have deliveries arriving on the day of the closure or specific medical requirements that can influence the closure decision or any conditions applied to the decision. Any feedback provided will be reported to Council to inform their decision making.

#### **Traffic Management Plans**

- 4.8 The physical act of undertaking any works within road reserve, including temporarily closing a road, requires an appropriate and approved traffic management plan.
- 4.9 Traffic management plans can only be approved for Council by a qualified Site Traffic Management Supervisor (STMS). Several Council staff hold this qualification and investigate and approve traffic management plans. The views of the Emergency Services are sought by the Council STMS when reviewing the traffic management plan.
- 4.10 The requirements for a traffic management plan and the roles and responsibilities of a qualified STMS are set out in the NZTA Code of Practice for Temporary Traffic Management.
- 4.11 A traffic management plan is a living document that is specific to the location of the closure in question. It must be designed by a qualified STMS, who has been commissioned by the event organiser. The event organiser's STMS is then responsible for all facets of the traffic management plan and its physical implementation. There are several dedicated traffic management companies within Nelson who provide this service.
- 4.12 The traffic management plan must also be appropriate to the situation it has been designed for and, as a living document, must be monitored and updated by its designer as site conditions change. For example, changing weather conditions or increasing traffic volumes may necessitate a change to the traffic management plan and its implementation.

- 4.13 This means a traffic management plan that is appropriate at the time of approval may no longer be appropriate if conditions change during the time of the closure. The event organiser's STMS is responsible for managing this as defined in the Code of Practice for Temporary Traffic Management.
- 4.14 If, during the implementation of the temporary road closure, conditions have changed such that the traffic management plan is no longer appropriate, the Police or a qualified STMS have the authority to require the event organiser to cease activity and make the site safe before the road closure can be enacted.

#### **Event Health and Safety**

- 4.15 Schedule 10 of the Local Government Act 1974, Clause 11C, states that when Council approves the temporary closure of a road in accordance with Clause 11(e), the status of the road changes from being a legal 'road'. This enables events like the Port Nelson Street Races to take place on legal road even though the racing vehicle speeds exceed the legal speed limit.
- 4.16 None the less, Council must be assured the event organiser informs all participants of the closure conditions and their personal responsibilities to ensure their safety.

#### 5. Discussion

5.1 Officers will have copies of the closure application forms at the Council meeting but have not included copies within this report as Officers often work closely with event organisers to help them locate their events. This can result in amendments to the final closure proposal that are not captured in the original application form.

#### **Previously Processed Applications**

#### **Tug of Peace**

- 5.2 The Nelson Tasman Hospice Trust has requested the closure of Trafalgar Street, from Hardy Street to Selwyn Place for the Tug of Peace event on Wednesday 28 January from 11:30am until 2:00pm (refer to attachment 1 for a map).
- 5.3 This is an annual charity event to raise awareness for the Nelson Tasman Hospice.
- 5.4 Council officers placed an advert within the Nelson Mail on Saturday 22 November 2014 advising of the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.5 No feedback was received by the feedback closure date of 5 December 2014.

5.6 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council.

#### **Buskerburgoo Street Theatre and Buskers Festival**

- The Nelson City Council Festivals Team have requested the closure of Trafalgar Street, from Hardy Street to Selwyn Place for the Buskerburgoo Street Theatre and Buskers Festival event, daily from Thursday 29 January until Saturday 31 January 2015, from 8:00am until 2:00pm (refer to attachment 1 for a map).
- 5.8 Council officers placed an advert within the Nelson Mail on Saturday 3 December 2014 advising of the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.9 No feedback was received by the feedback closure date of 12 December 2014.
- 5.10 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council.

#### **Monster Slide**

- 5.11 In mid November 2014 Council officers were approached by organisers of the Monster Slide event seeking the temporary closure of Collingwood Street. The closure duration was proposed to be from 4:00am until midnight on 2 February 2015. The event requires the temporary closure of (refer to attachment 2 for a map):
  - Collingwood Street (from Manuka Street to Brougham Street);
  - Bronte Street (from Richmond Avenue to 30 metres west of Collingwood Street).
- The organisers confirmed the slide would require an area approximately 300 metres long by 6 metres wide that sloped at about 10 degrees. The preferred site was Collingwood Street, between Manuka Street and Brougham Street. The slide would be an inflatable structure, like a children's bouncy castle and its surface would be lubricated by water and a substance similar to baby oil.
- 5.13 An advert was placed in the Nelson Mail on Saturday 29 November 2014 calling for feedback on the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.14 The request for feedback closed on Friday 12 December 2014 and five objections were received from 3 properties (refer to attachment 3). The organiser was advised that Officers had received more feedback on this closure than other closures and the closure application may not be approved. This advice was later confirmed with the organiser and an advertisement placed in the Nelson Mail advising of this.

- 5.15 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council. The residents who provided feedback have been similarly advised.
- 5.16 Organisers have indicated they will appoint a qualified traffic management company to design their traffic management plan. Council Officers have sought initial views from the Emergency Services who indicated they have no issues at this early stage.
- 5.17 This application is 'live' and subject to negotiation. It is understood that a resource consent application is being prepared and further aspects of the event will be assessed through that process. Updates and any other background information which comes to hand will be presented at the Council meeting.
- 5.18 Council Officers recommend a bond or deposit is requested to cover potential damage to property and to cover the use of water.
- 5.19 Council Officers have contacted other local authorities to determine any issues or conditions that they have applied to the organiser of the Monster Slide event:
  - Dunedin City Council has confirmed that the slide will be located within a grassed reserve so no road closure is required;
  - Dunedin City Council has not requested a bond for their version of this event, as they view their location as limiting the likelihood of any damage to Council property;
  - New Plymouth District Council has imposed very few conditions other than a traffic management plan which will detail access for emergency services.

#### Mike Pero Trolley Derby

- 5.20 In early November 2014, Council officers received a temporary road closure application for the annual Mike Pero Trolley Derby. This closure is proposed for Saturday 14 March 2015 from 7:00am until 7:00pm.
- 5.21 The Mike Pero Trolley Derby is a participation event for non-motorised carts or trolleys. The event requires the temporary closure of (refer to attachment 4 for a map):
  - Collingwood Street (from Manuka Street to Brougham Street).
- 5.22 An advert was placed in the Nelson Mail on Saturday 22 November 2014 calling for feedback on the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.23 No feedback was received by the closure date of 5 December 2014.

5.24 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council.

#### **New Temporary Road Closures**

#### **Cricket World Cup and Uniquely Nelson Market Day**

- An application was received for a temporary road closure for both the Cricket World Cup Festival and the Uniquely Nelson Market Day on the morning of 14 February 2015. Although these are separate events, the areas to be closed are adjacent to each other. Therefore the closure application has been submitted as one. As such the traffic management is also to be managed under one traffic management plan.
- 5.26 The extent of the closures are (refer to attachment 5 for a map):
  - Trafalgar Street (from Bridge Street to Hardy Street) from 5am until 5pm;
  - Trafalgar Street (from Hardy Street to Selwyn Place) from 5am until 7pm;
  - Selwyn Place (from Trafalgar Square West to Trafalgar Street East) from 5am until 7pm;
- 5.27 Council officers placed an advert within the Nelson Mail on Saturday 29 November 2014 calling for feedback on the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.28 No feedback was received by the closure date of 12 December 2014.
- 5.29 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council.

#### **Celtic Pipe Band Championships**

- 5.30 The Royal New Zealand Pipe Band Association has requested the closure of three streets within the Central Business District for the Celtic Pipe Band National Championships. The competition involves a parade of 45 pipe bands on the morning of 14 March from 8:00am until 12:30pm and requires the temporary closure of (refer to attachment 6 for a map):
  - Halifax Street (from Trafalgar Street to Halstead Street);
  - Trafalgar Street (from Grove Street to Bridge Street);
  - Bridge Street (from Trafalgar Street to Montgomery Carpark);
  - Hathaway Court (car park only) will be closed from 6:00am Friday to 8:00pm Saturday. Please note, Hathaway Terrace will not be affected.

- 5.31 This event will coincide with the Mike Pero Trolley Derby which takes place on Collingwood Street. Traffic attending the trolley derby will not be able to access the event via Halifax Street.
- 5.32 Council officers placed an advert within the Nelson Mail on Saturday 22 November 2014 calling for feedback on the proposed closure. The organiser was also asked to inform adjoining properties, notifying them of the event.
- 5.33 One objection was received (refer to attachment 7) by the feedback closure date of 12 December 2014. The organiser has not yet been advised of the objection.
- 5.34 Subsequent review of the legislation has highlighted the error in interpretation. The organiser has been advised of the error and that the matter will be put before Council.

#### **Information of Upcoming Temporary Road Closures**

#### Weet-Bix Kids TRYathlon

- 5.35 In early January 2015, Council officers received a temporary road closure application from Sport Tasman for the annual Weet-Bix Kids TRYathlon. This closure is proposed for Sunday 8 March 2015 from 6:00am until midday.
- 5.36 The Weet-Bix Kids TRYathlon is a national sports participation event run for school aged children. The event requires the temporary closure of:
  - Beach Road (from 17 Beach Road to Golf Road);
  - Golf Road (from Beach Road to Parkers Road);
  - Hounsell Circle.
- 5.37 An advertisement calling for the views of affected properties will be placed in the Nelson Mail on Saturday 24 January 2015. The organiser will also be asked to inform adjoining properties, notifying them of the event.
- 5.38 The results of this feedback will be presented to a meeting on 12 February 2015.

#### **Organised Stopping Distance Demonstrations**

- 5.39 In March 2015 Council officers propose to hold the Organised Stopping Distance Demonstrations as part of a road safety campaign to show how long it takes for a car to stop when travelling at different speeds. The temporary closures are required between 5:30 pm until 7:30 pm at four separate locations on four different dates.
- 5.40 Access to and from properties within the closed sections of road will be provided if necessary, but there may be delays of up to 15 minutes. The event requires the temporary closure of:

- Nile Street (from Alton Street to Collingwood Street) on Monday 16 March 2015;
- Bisley Walk (Tahunanui Beach Reserve by the playing fields) on Tuesday 17 March 2015;
- Tipahi Street (from Tukuka Street to Motueka Street) on Thursday 19 March 2015;
- Atawhai Crescent (from the north intersection with State Highway 6 to Rainbow Drive) on Friday 20 March 2015.
- 5.41 An advertisement calling for the views of affected parties will be placed in the Nelson Mail on Saturday 24 January 2015. Adjoining properties will be informed of the proposed event.
- 5.42 The results of this feedback will be presented to a meeting on 12 February 2015.

#### 6. Options

- 6.1 In each case Council has two options, either to allow or decline the road closure applications.
- 6.2 To allow the application, Council should consider the following conditions:
  - An appropriate, approved traffic management plan;
  - The approval of emergency services (Police, Fire and Ambulance) as part of the traffic management plan approval;
  - Public liability insurance.

# 7. Assessment of Significance against the Council's Significance Policy

7.1 The recommendations outlined in this report are not considered significant in terms of the Council's Significance Policy.

#### 8. Alignment with relevant Council Policy

- 8.1 The recommendations outlined in this report are directly aligned to the requirements of:
  - The Local Government Act 1974, Schedule 10, Temporary Prohibition of Traffic;
  - The Local Government Act 2002, Clause 78, Community Views in Relation to Decisions.
- 8.2 Council may wish to consider the applications in the context of the attractiveness and vibrancy they add to Nelson for its residents.

#### 9. Consultation

9.1 Council's current temporary road closure procedures enable Council officers to seek the views and preferences of those directly affected by any proposed closure in accordance with Clause 78 of the Local Government Act 2002. Any objections or feedback provided will be reported to Council to inform any decisions made to approve the temporary closures or not.

#### 10. Inclusion of Māori in the decision making process

10.1 Māori have not been specifically included for in the decision making requirements of this report.





We accept the inconvenience because this is such a wonderful community event, which has become an important part of the Nelson summer scene, and a strong Nelson tradition.

But the monster slide isn't a community event – it's just a commercial, money-making venture. There are no particular benefits to the Nelson community. It's not something that the community gets involved in, it's not as if it's for a sports event or cultural or community event. It doesn't have to happen. Nelson will be no worse off if it doesn't take place.

It's not environmentally friendly, as it will presumably have a very high water usage. The waste of water at this time of the year isn't sensible, particularly if Nelson is heading into a dry spell.

It is a real inconvenience to have the road closed for a whole day, and it shouldn't be foisted on residents twice a year. This closure is particularly inconvenient, because it's for 24 hours – so residents will have to leave their cars parked away from their homes for 2 nights.

It's a holiday weekend, and there could be people returning home, who've been away for the weekend—they'd be unable to unpack their cars until after midnight. At least with the Trolley Derby the road is cleared about 6 or 7pm. The midnight closure makes it much more inconvenient than the Trolley Derby.




Green represents Uniquely Nelson Closure for Market Day 5am – 5pm Red represents Cricket world Cup fan zone 5am – 7pm
