#### 4.0 MAYORS REPORT

#### 4.1 Opening Prayer

His Worship the Mayor said that he would like to discuss with Council the wording of the current opening prayer for Council Meetings.

## 4.2 Community Plan 2009/2019

His Worship the Mayor thanked Councillors for the work they had done on the Draft Community Plan. He said that Councillors had conducted themselves in a very good spirit.

# 4.3 Announcement of job losses at Sealord

His Worship the Mayor said that Council did not get an advanced briefing on the proposed job losses at Sealord. He reminded the meeting that Sealord was a big user of Council facilities and there needed to be a discussion with Sealord and the other "big players" in the City about the effects of these cuts.

Councillor Thomas agreed, saying that regarding Sealord it was absolutely critical that Council has dialogue with the local business community.

Councillor Cotton agreed saying he would like Council to invite the Sealord Chief Executive here to give Council a briefing and then Council could see how it could help.

# **4.4** Meeting of Unitary Councils

His Worship the Mayor gave a brief report on a meeting he had attended of the Unitary Authorities.

# 4.5 **SOLGM Meeting**

The Chief Executive reported on a recent SOLGM Meeting he had attended where Nelson MP, Hon Nick Smith, had given a briefing on the likely direction of the proposed RMA reforms. His Worship the Mayor said that he intended to invite Mr Smith to talk to Council in the near future.

#### 4.6 Local Government Metro Meeting

His Worship the Mayor gave a brief report on the recent Local Government Metro Meeting which had been addressed by the Deputy Prime Minister Mr English who had said Government wish to speed up the local government decision making process and he believed that it over-consulted and takes a long time to make a decision.

#### 4.7 Zone 5

Councillor Miccio reported on a meeting of Zone 5 that he had attended. The President and Vice President had spoken of the urgency of the job summit and the economic state of the country. The level of debt in local government was also discussed and it was advised that this was tripling around the country in an attempt to keep rates within the CPI and to keep on with infrastructure work.

There was, he said, a big push being made for local government to have access to funds at low interest rates. The meeting also had a discussion on the state of affairs in the Country in general and local government in particular.

In answer to a question regarding progress of amalgamation in the Auckland area the Chief Executive reported that the Auckland situation was subject to a Royal Commission. The report of that Commission was due out at the end of March and the Minister of Local Government had signalled that there will be some changes to the Local Government Act and those changes are likely to be enabling generally not just specifically focused on Auckland.

In answer to a question with regard to the state of the Combined Shareholders Group, His Worship the Mayor said he had had a breakfast meeting with Richard Kempthorne yesterday where he had discussed the relationship with Tasman District Council. The Mayor said it was a work in progress and he will be reporting back to Council in the near future.

#### 4.8 Tribute to the late Councillor Gourdie

Councillor Barker reported that he had attended the funeral on Saturday of the late Councillor Ian Gourdie. Councillor Barker paid tribute to Mr Gourdie's time on Council saying that he had served from 1974 - 1984 during which time he had been Chairman of Councils Works Committee.
